Brewer Basketball Boys Fall to Chisholm Trail

The Brewer boy's basketball team lost a close one to Chisholm Trail last week, and coach Jason Porostovsky said his team gave a good effort.

Albert Street Drop-Off Recycling Station Changes

White Settlement residents recycled 873 tons of items in 2024 in the curbside recycling carts that otherwise would have ended up in landfills.

Frontier Waste Management kept the recycling drop-off station located at 8212 Albert Street running while the city transitioned to curbside recycling.

The City has monitored the usage of the recycling drop-off station closely, and as it has heavily declined, the station will be closing for good on Jan. 31.

The drop-off station will be replaced with a cardboard only recycling dumpster so those who have more cardboard than their carts can handle still have a place to take it.

Public Invited to Submit Vital Data for 38-County Flood Planning Effort

The Region 3 Trinity Regional Flood Planning Group (Trinity RFPG) urges anyone affected by flood-related issues to participate in the recently launched online data collection survey and interactive web map. The survey and map are available at <https://trinity.halff.com/> and through the Public Comment page, which is open now through Tuesday, Feb. 11, for consideration in the 2028 Trinity Regional Flood Plan.

Participation from the general public and groups with flood-related responsibilities will strengthen the RFPG's ability to update and maintain a flood plan that represents local flood planning resources, flood-related risks, flood mitigation needs and potential solutions. Individuals or organizations that participated during the initial cycle of Regional Flood Planning are still encouraged to review the updated interactive web map and submit updated information to keep planning efforts current and address any new flooding concerns.

When visiting the data collection website, representatives from cities and other entities must register by providing an email and creating a password. Once logged in, fewer than 25 questions and an interactive map prompt a review of flood history, storm drainage systems and critical infrastructure.

Members of the general public are also encouraged to participate and share their knowledge of flood-prone areas and zones where flood mitigation might be needed with the Trinity RFPG. To access the public input map, users will need to provide their name, physical address and email address. The RFPG will use contact information only to confirm unusual or extreme responses. Most public responders will not be contacted.

Helping Children Develop Healthy Device and Media Habits

Can parents control what advertising their children see on Facebook? How do parents limit the amount of time their children spend on Instagram?

A new parent tool, the Glossary of Digital Media Platforms, offers the answers and will be handy for parents of children trying out new phones or other tech-related holiday gifts. The American Academy of Pediatrics Center of Excellence on Social Media and Youth Mental Health developed the free resource, which contains detailed information on popular digital platforms, including Apple, Discord, Facebook, Instagram, Pinterest, Snapchat, TikTok and X, with more to come.

“Parenting around media can be so challenging,” said Jenny Radesky, MD, FAAP, co-medical director of the Center of Excellence. “Figuring out what apps and settings are best for your family is an important part of the conversation. At the center, we created the Glossary of Digital Media Platforms to make it a little easier for parents to learn about each app and figure out what settings and tools exist to keep their kid safe while connecting online.”

Users click on a platform to learn about its default and customizable safety settings; messaging and friending controls; screen-time management settings; parental controls and more.

Parents aren't the only ones looking for assistance when it comes to the online world. Pediatric providers, teachers and others who work with children and teens can introduce the glossary briefly during clinic visits, back-to-school nights, in newsletters, or other communications and encourage families to have conversations about safe and balanced relationships with social media. The tool can also facilitate conversations on concepts like private versus public accounts, time limits and how to block or filter upsetting content.

Here are some examples of how the glossary can be used:

- If children have iPhones, parents can

learn more about the Family Sharing feature, which includes settings to limit who a child can contact, downtime/do-not-disturb settings and the Ask To Buy option that requires a parent to approve purchases.

- If social media and notifications are distracting teens at night, families can use the glossary to look up apps and how to silence notifications or activate other nighttime settings.

- For teens who are stressed out by negative content on social media feeds, the glossary contains information on tools to curate feeds and block and filter content.

- If a child's school has a phone policy, families can look up device or app settings to silence distracting apps during school hours.

The glossary joins a roster of resources available at Center of Excellence on Social Media and Youth Mental Health, which includes conversation starters for parents concerned about how their children are using social media. The center's activity cards can help young children build healthy relationships with media and their devices before they grow into teens and young adults.

Megan Moreno MD, MEd, MPH, FAAP, co-medical director of the Center of Excellence, urges parents and other adults to avoid taking a doom-and-gloom approach when talking about the sometimes-dangerous social media landscape with kids.

Dr. Moreno said, “We can choose open-mindedness. We can choose curiosity. We can choose evidence over hype, and we can stay centered on our children and families.”

Fort Worth Stock Show & Rodeo Parade Draws Crowd

Thousands of spectators lined the streets on Main and Houston downtown to watch the annual Fort Worth Stock Show & Rodeo Parade, that began in 1896. More than 3,000 horses and over 4,000 riders and participants walked the 2-mile route.

Marching bands and horse drawn carriages were crowd pleasers, as no motorized vehicles are allowed in this parade.



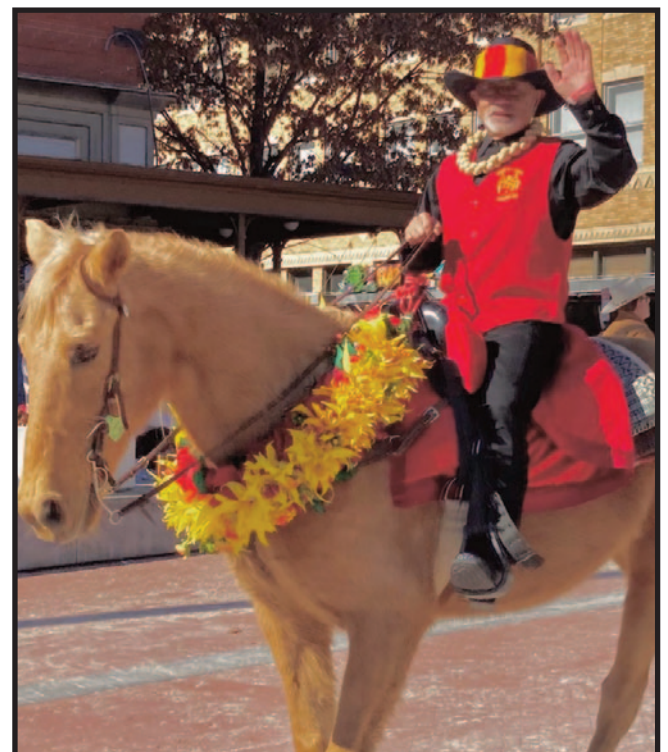

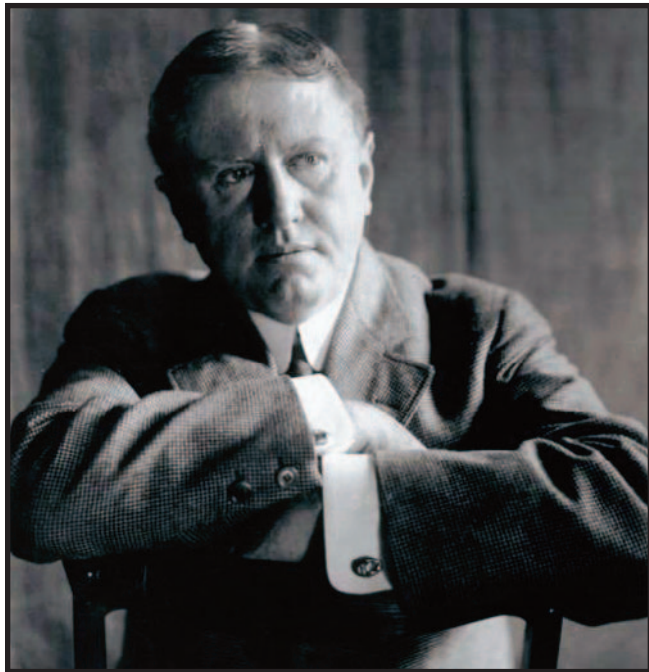

Texas History Minute by Dr. Ken Bridges

Short Story Author - William Sydney Porter



He was best known for a short pen name, "O. Henry." The man behind the stories, William Sydney Porter, was a complicated character with a sharp imagination. Porter wrote hundreds of stories in his short career and became one of the best-known short story writers of the twentieth century.

Porter was born in Greensboro, North Carolina, in 1862. His father was a doctor and his mother died of tuberculosis when he was a child. He showed a deep imagination and strong artistic talents as a child. He loved reading from an early age. As a teenager, he began working at his uncle's drugstore as a pharmacist and drew sketches of the customers in his spare time.

In 1882, he moved with a friend to South Texas to attempt to rehabilitate his shaky health. He worked for a time on a sheep ranch as a ranch hand and a cook. Two years later, he moved to Austin to work as a pharmacist. It was in Austin that Porter began writing. Initially, it was a hobby, but it gradually took up more and more of his time.

In 1887, he married and took up a new job. Porter worked for four years at the Texas General Land Office drawing maps and took a job as an accountant at an area bank in 1891. However, three years later, the bank came across several accounting errors, accused him of embezzlement, and fired him. At that point, he took up writing full time, publishing his own weekly humor magazine, *The Rolling Stone*. Though pop-

ular, the magazine failed within a year and Porter soon found work with *The Houston Post*.

Not long after the move to Houston, federal auditors charged him with embezzlement from his former bank job. He was arrested but released on bail. He soon fled to New Orleans where he continued to write and took up the pen name of O. Henry after a conversation with a friend. He then fled to Honduras but returned to the United States when his wife's health collapsed. His wife died within weeks of his arrival, and he was again arrested.

The trial was held in Austin, where he was sentenced to five years in prison in 1898. Ironically, the same courthouse today is owned by the University of Texas and has been rechristened O. Henry Hall.

He was released in 1901 for good behavior. In 1902, he moved to New York where he landed a job writing weekly stories for *The New York World Sunday Magazine*. He would write more than 300 short stories between 1902 and his death, many known for a sudden, surprise twist at the end.

Perhaps his most famous story was "*The Gift of the Magi*," originally appearing in December 1905. It is the touching tale of a young couple in turn-of-the-century New York who want to get something special for each other for Christmas but have no money. Unbeknownst to each other, they give up something they prize to buy their gifts. The wife sells her luxuriant hair to afford a silver chain for her husband's pocket watch. The husband, however, had sold his watch to pay for jeweled hair combs for his wife which were so popular at that time. The story has since been retold many times and dramatized on screen in many forms.

Two other stories included "*The Cavalero's Way*," (1907) which introduced The Cisco Kid, a character reproduced by many other authors; and "*The Ransom of Red Chief*," which appeared in *The Saturday Evening Post* in 1907 as the tale of two kidnapers who kidnap a rich, spoiled brat in hopes of ransom but end up paying the father for him to take the incorrigible child back.

His heavy drinking steadily took its toll on him. It cost him his marriage. His second wife left him in 1909. He descended further into the bottle and died in 1910 at age 47.

In spite of his sad end, he was praised in later years. Schools in Garland and Austin were named for him as well as in his native Greensboro.

In 1918, the prestigious O. Henry Award was established in his memory for outstanding short story writers.

Free Feline Fix Day Jan. 29

Texas Coalition for Animal Protection (TCAP) recently announced the first Free Fix Day of 2025 - Wednesday, Jan. 29! In 2024, TCAP sterilized over 16,000 feral and community cats!

During the Free Fix Days, TCAP provides free sterilizations and rabies vaccines for feral and community cats. This event will take place at each of the seven TCAP clinics located in Allen, Arlington, Denton, Garland, Hurst, Joshua, and Weatherford. Each location will serve 75 cats on a first-come, first-served basis.

There's no limit to how many cats each caregiver can bring, and no appointment is needed.

Cats must arrive in individual live traps or pet carriers and will receive an ear tip as part of the process.

For every cat brought in, the Caretaker will receive a voucher for a free spay or neuter and rabies vaccine for another cat at a future date. Our team will help you schedule the additional service when you redeem your voucher.

If you're outside the first 75 cats in line, please wait! We'll provide one voucher per cat for the next 75 cats in line.

*Please note that the line will close promptly at 9 a.m., and only caregivers with cats in line will receive vouchers.

TCAP will cover any additional fees for in-heat, cryptorchid, or pregnancy procedures.

Caregivers are responsible for elective services, such as vaccines, pain medication, or viral testing.


