Soccer: WHHS Cougar Boys Defeat Dunbar, Lady Bobcats Find a Win Against Diamond Hill

The Western Hills boys soccer team defeated Dunbar on Friday to improve to 8-2 in district competition, and coach Matt Collins had nothing but praise for his team and their opponent.

“Dunbar gets better every time we play them,” Collins said. “I thought we controlled the game pretty well. We were patient and figured out how to get some goals. Patience has been the key word to our whole season.”

Collins said he had a few standouts in the game as well.

“Anthony Juanes always seems to score against Dunbar,” Collins said. “He had two on the night. Gustavo Riveros was our best player. He made two incredible passes to create our first two goals.”

As the playoffs approach, Collins said he feels like his team is in good position to have a good showing.

“I think we are set up well for the post season,” Collins said. “We are an experienced team. We just need to take it day by day and focus on improving the little things that all add to being great.”

Over at Benbrook, the Lady Cats defeated Diamond Hill on Friday to remain atop the district standings, and coach Luz Castillo said that one group in particular deserves recognition.

“The team had another clean sheet from the defensive line of Riley Hoyler, Taryn King, Brooke Moreno, Jessica Anzaldua and Yadira Ordóñez,” Castillo said. “The ladies really picked up the pressure and ended the game with a 4-0 win.”

Castillo said she had a couple of strong performances on the offensive side of the ball as well.

“Center midfielder Vivian Carpenter made the first goal of the match and finished the game with two assisted goals,” Castillo said. “Striker Campbell Cox had two goals and an assist, and Lily Carias made had a goal too.”

As the regular season winds down, Castillo said she likes how her team is playing.

“There are only two more district games left in our season,” Castillo said on Sunday. “Our major objective is to continue to play with urgency and intensity, and to keep the other team at shutout. We are currently first in district and are preparing to take on playoffs.”

On the diamond, the Benbrook baseball team went 1-3 in the FW Arlington Heights/FW Southwest tournament this past weekend and coach Justin Chavez said it was a good opportunity for his team.

“We played tough competition all weekend, but it will benefit fit us in the long run with four freshman and three sophomores in the lineup almost every game,” Chavez said. “We were able to beat Granbury 6-5 by scoring two runs in the last inning. Ethan Smith pitched a great game and had an assist from the outfield in the last inning to keep the game to a one run score which allowed us to win in the end.”

Giuliano Martinez started the last inning off with a base hit, followed by Fabian Ortega and Santiago Cruz with hits to load the bases.

“Sebastian Martinez came through with the final hit to score G, Martinez and Ortega,” Chavez said. “Three freshman and one sophomore to come through in that situation will only make us better come playoffs.”

The Bobcats were 4-4-1 on the regular season following the tournament, and Chavez said things are going accoring to plan early on.

“We have played some really tough competition,” Chavez said. “We do that for a reason— not to win, but to get ready for the playoffs. We want to see are guys in adverse situations, and hopefully overcome them. If we don’t, then we have to learn from it and be ready the next time. Overall, we are excited about the season. Although we are young we still have the same expectations of making a deep run in the playoffs and are excited about this season and the next three to four years. We have a special group of ball players.”

Obituary



Greta Wade Vargas

Greta Wade Vargas passed on and went to be with the Lord on Feb. 26, 2023 after several weeks of illness. Greta was 73.

The family plans a private burial.

She was born on Jan. 18, 1950 to Margaret and L.R. Winfrey at All Saints Hospital in Fort Worth.

Greta attended Central Elementary, Brewer Junior High and Brewer High School in White Settlement, graduating in 1968.

She was a lifelong resident of the Fort Worth/White Settlement area with the exception of a short period, 1971 and 1972, where she and her husband Walter Wade lived in Heilbronn Germany while he served in the army. They were able to travel to the French Riviera, Rome, Italy and London, England. They were married fourteen years. Greta lived in Texas, Fort Worth and White Settlement all her life.

She enjoyed roller skating, dancing and all kinds of music. She worked at John Peter Smith hospital in the Medical Records Department, as a Security Guard and a General Dynamics assembling circuit boards. and published the book, Northern Catchers.

Greta loved the Lord and her family. She was kind to everyone, helping others whenever she could and was a faithful prayer warrior. She attended The Baptist Temple in White Settlement.

She is survived by her two children: son Jeff Wade and his wife Karin of Benbrook, Texas and daughter Darla Baughman, her husband Brian, and grandson Preston Baughman of Dover, Ohio, and her two brothers John Winfrey and his wife Marietta of Lawrence, Kansas and Steven Winfrey of White Settlement.

19th-Century American Lawyer and Soldier -

William Barret Travis *by Dr. Ken Bridges*



William Barret Travis is perhaps one of the most memorable figures from the Texas Revolution and the siege of the Alamo. His name has since been honored with the naming of Travis County, a park in San Antonio, and numerous schools across the state. Like many heroic figures, his life was one fraught with difficulty.

Travis was born in Saluda County, South Carolina, on Aug. 1, 1809. He was the first of 11 children born to farmer Mark and Jemima Travis. He came from a family of pioneers who had settled in Virginia as early as 1627. Eager for new opportunities, the family headed westward and settled in southern Alabama in 1817. He briefly became a school teacher before gaining his law license through an apprenticeship in 1828.

Everything in his life seemed to be going in his direction at this point. He was ambitious, becoming steadily more successful, and making himself an important part of the community. In 1829, his new wife gave birth to their first child. In addition to his law practice, he started a newspaper, the *Claiborne Herald*. He joined the local Masonic lodge and also joined the Alabama Militia. But in less than two years, he lost it all.

His weekly newspaper turned into a disaster as his continual typesetting mistakes, missed deadlines, and poor decisions pushed the once-promising publication into insolvency. He found himself unable to attract any significant clients to his law firm. Of the few clients he had, he was unable to collect any legal fees or awards. The bills piled up, no money was coming in, and he now faced the suspected infidelity of his wife.

By early 1831, he owed \$834 to various creditors, an immense sum at the time. Unable to pay, he was taken to court and found liable. By March, an order for his arrest was made for the unpaid debts. Buried in debt and on the run from the law, Travis left Alabama in disgrace.

He went to Texas to recover his fortunes. He started a modest law firm at Anahuac, near modern-day Houston. In 1832, he was arrested following a legal dispute over three slaves who had escaped from Louisiana. The incident touched off a violent encounter with the Mexican

Army that left six dead.

In 1834, Travis moved his law practice to San Felipe as relations between Mexico and Texas settlers deteriorated. By 1835, he was made a lieutenant colonel in San Antonio and ordered to recruit volunteers for the defense of the city, but he found few people willing to join him. In early 1836, troops began reinforcing the old mission at the Alamo, which at that time was just outside San Antonio. By mid-February, Col. James Neill took a leave of absence to attend to his family, leaving Travis in command of about 50 men. One hundred more soon joined, under the command of Jim Bowie.

In spite of Gen. Sam Houston's orders that the mission be abandoned, Travis and the other men decided to make their stand. He sent urgent appeals for reinforcements. On Feb. 24, he sent an open letter addressed "To the People of Texas and All the Americans in the World," asking for troops "in the name of liberty, of patriotism, and everything dear to the American character." He proclaimed, "I shall never surrender or retreat."

By the time the final siege started, there were only 188 defenders at the Alamo, compared to the thousands of soldiers attacking the mission.

On March 6, the final attack started, and the men of the Alamo faced their destiny. Travis died at the Alamo on that fateful day. He lived a short 26 years, but in one fateful moment in history, he became a legend.

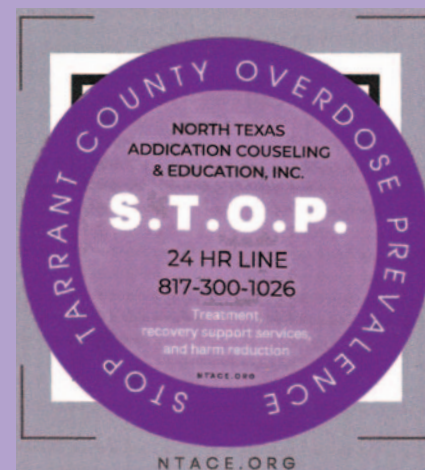
